**GENERAL RELEASE AND IDEMNIFICATION AGREEMENT**

I hereby represent that I am the parent or legal guardian or "Participant", who is under the age of 18. For and in consideration of Premier Flight Academy permitting Participant to participate voluntarily in a Premier Flight Academy Youth Camp to be held during 2011-2012 at Premier's facility in Cleveland, Ohio, hereafter referred to as "Camp", I hereby expressly assume all the risks associated with the camp, and I release Premier Flight Academy, its trustees, officers, employees, students, and agents from all claims, demands, suits, causes of action, or judgments which participant or I ever had, now have, or may have in the future or which our heirs, executors, administrators, or assigns may have, or claim to have against Premier Flight Academy its trustees, officers, employees, students, or agents, arising out of or in any way connected with the camp, for all personal injuries, known or unknown, property damages, or claims for wrongful death, caused by the acts, omissions or negligence of Premier Flight Academy, its trustees, officers, employees, students, or agents.

**I FURTHER AGREE TO INDEMNIFY AND HOLD HARMLESS PREMIER FLIGHT ACADEMY, ITS TRUSTEES, OFFICERS, EMPLOYEES, STUDENTS, AND AGENTS FROM ALL CLAIMS, DEMANDS, SUITS, CAUSES OF ACTION, OR JUDGMENTS WHICH PARTICIPANT OR I EVER HAD, NOW HAVE, OR MAY HAVE IN THE FUTURE OR WHICH OUR HEIRS, EXECUTORS, ADMINISTRATORS, OR ASSIGNS MAY HAVE, OR CLAIM TO HAVE AGAINST PREMIER FLIGHT ACADEMY, ITS TRUSTEES, OFFICERS, EMPLOYEES, STUDENTS, OR AGENTS, ARISING OUT OF OR IN ANY WAY CONNECTED WITH THE CAMP FOR ALL PERSONAL INJURIES, KNOWN OR UNKNOWN, PROPERTY DAMAGES (INCLUDING LOST OR STOLEN PROPERTY), OR CLAIMS FOR WRONGFUL DEATH, CAUSED BY THE ACTS, OMISSIONS OR NEGLIGENCE OF PREMIER FLIGHT ACADEMY, ITS TRUSTEES, OFFICERS, EMPLOYEES, STUDENTS, OR AGENTS, AND ON PREMIER FLIGHT ACADEMY AND IN PREMIER FLIGHT ACADEMY'S NAME DEFEND AT MY OWN EXPENSE ANY SUCH CLAIMS, DEMANDS, SUITS, CAUSES OF ACTION OR JUDGMENTS DESCRIBED ABOVE. I ALSO AGREE TO BE RESPONSIBLE FOR ANY PROPERTY DAMAGE OR PERSONAL INJURIES THAT PARTICIPANT OR I MAY CAUSE BY INTENTIONAL OR NEGLIGENT ACTS WHILE PARTICIPATING IN THE CAMP.**
